## DISTRIBUTION NOTICE

Aberdeen Income Credit Strategies Fund (NYSE: ACP) (the “Fund”), a closed-end fund, today announced that it paid on January 28, 2020, a distribution of US\$0.12 per share to all shareholders of record as of January 21, 2020 (ex-dividend date January 17, 2020).

The Fund’s distribution policy is set to provide investors with a stable monthly distribution out of current income and, to the extent necessary, paid-in capital. Return of paid-in capital includes distributions paid by the Fund in excess of its net investment income and net realized capital gains and such excess is distributed from the Fund's assets. A return of capital is not taxable; rather, it reduces a shareholder's tax basis in his or her shares of the Fund. The Fund is required to distribute realized net capital gains, if any, on an annual basis, which may be deemed part of a distribution where possible.

Under U.S. tax rules applicable to the Fund, the amount and character of distributable income for each fiscal year can be finally determined only as of the end of the Fund’s fiscal year. However, under Section 19 of the Investment Company Act of 1940, as amended (the “1940 Act”) and related Rules, the Fund may be required to indicate to shareholders the estimated source of certain distributions to shareholders.

The following table sets forth the estimated amounts of the sources of the distribution for purposes of Section 19 of the 1940 Act and the Rules adopted thereunder. The table has been computed based on generally accepted accounting principles. The table includes estimated amounts and percentages for this distribution and for the cumulative distributions paid relating to fiscal year to date (11/01/2019 - 12/31/2019), from the following sources: net investment income; net realized short-term capital gains; net realized long-term capital gains; and return of capital. The estimated composition of the distributions may vary from month to month because the estimated composition may be impacted by future income, expenses and realized gains and losses on securities and currencies. The timing of the rights issue completed in November 2019, increased the average cash balance of the fund in the period while the proceeds of the rights were invested. This affected the amounts reported as composition of the distribution in the table below.
